

HARDIN COUNTY BOARD OF SUPERVISORS
MINUTES - OCTOBER 29, 2008
WEDNESDAY – 10:00 A.M.

Chairman Ed Bear called the meeting to order. Also present was Supervisors Jim Johnson and Erv Miller. Gary Mauer, Justin Ites, John Butters and Kelly Collins.

Johnson moved, Miller seconded to approve the minutes of October 21, 2008. Motion carried.

Miller moved, Johnson seconded to abate the property tax for the new street being constructed near the new college facility parcel #002520000002. Motion carried.

Johnson moved, Miller seconded to allow homestead credit for 123 West Maple, Hubbard, Iowa . Parcel # 711-000-820-000-000. West 85 feet of Lots 2 & 3, Block 2, Hoover's Addition to Hubbard, Hardin County, Iowa. Disallowed in error. Motion carried.

Miller moved, Johnson seconded to disallow the homestead credit for 211 Sarah, Iowa Falls, Iowa 50126. Parcel# 590-023-080-000-000. Lot 10, Block 3, Foster's Addition, Iowa Falls, Hardin County, Iowa. Motion carried.

Secondary Roads:

Johnson moved, Miller seconded to adopt Resolution 2008 28, Relating to Load Structures. Roll Call Vote: "Ayes": Johnson, Miller, and Bear. "Nays": None. Absent: None. Resolution 2008 – 28 is hereby adopted and on file in the Auditor's Office. Motion carried.

Miller moved, Johnson seconded to approve the installation of a manure pumping culvert 1 mile west of Buckeye with the landowner Mervin Vierkandt paying for the cost of the pipe and the county providing installation. Motion carried.

Drainage: D.D. #34

Johnson moved, miller seconded authorizing the drainage engineer to work with landowner/s for drainage problems in the district and authorize the drainage engineer to make recommendation to the trustees for action to take care of the problem. Motion carried.

HH 104-222

Miller moved, Johnson seconded to authorize the county crew to inspect drainage problems and report back to the Supervisors the findings. Motion carried.

D.D. # Big 4, Lat C

Johnson moved, Miller seconded to authorize county crews to inspect and make necessary repairs to the district. Motion carried.

Johnson moved, Miller to rescind the previous motion on D.D. HH 104-222 and to send onto Hamilton County. Motion carried.

Miller moved, Johnson seconded to adjourn until November 5, 2008.
